ABORTION	Supports abortion-on-demand throughout all 9 months of pregnancy, up to the moment of birth, for any reason or no reason at all.	The Party's official policy declaration explicitly condemns sex-selective abortions. Party policy declaration supports a Born Alive Infant Protection Act that would require babies who survive abortion be given life-saving medical care. A conflict exists between the Policy Platform and the Party Constitution, with respect to an abortion law. The Constitution (good) describes as a guiding principle of the party: "A belief in the value and dignity of all human life", whereas the policy declaration (bad) states that "A Conservative Government will not support any legislation to regulate abortion". The Party policy declaration pledges to implement a "National Adoption Strategy, including an awareness campaign to promote adoption". This is a great policy which, if implemented, would actually reduce the number of abortions in Canada. EUTHANASIA	Supports giving doctors the power to lethally inject their patients. Liberal government legalized this form of homicide in 2016, and have steadily loosened eligibility criteria to the point where today, Canadians are being approved for lethal injection because of poverty, inability to pay rent, having chronic allergies, and other "slippery slope" scenarios that Liberals denied would ever happen. Liberals passed Bill C-4 into law, the so-called "conversion therapy ban", which can land parents in jail up to five years for merely affirming their gender-confused son or daughter as the biological sex in which they were born. In recent years, the Trudeau Liberals have funnelled hundreds of millions of taxpayer dollars to push transgender ideology throughout Canada and around the world. ANTI- CHRISTIAN PERSECUTION	 In 2021, following a since-debunked allegation of mass graves at residential schools, the Justin Trudeau Liberals escalated division and fomented hatred against the Catholic Church. Their baseless and irresponsible insinuations started a hate-fueled crime spree against Christian churches, wherein nearly 100 churches since June 2021 have been set on fire or burned to the ground across the country, and another 100 have been vandalized. The media have almost totally ignored the wave of church burnings, but when they did finally ask Trudeau about it, he justified the arson attacks, calling them "understandable". In December 2024, a report was issued from a Liberal/NDP-dominated House of Commons Finance Committee which recommended that in its next budget, the government strip churches, Christian charities, and pro-life organizations of their charitable status. It attacked churches directly by recommonding an amendment to the Income Tax Act "to provide a definition of a charity which would remove the privileged status of 'advancement of religion' as a charitable purpose". 	 Many Conservative MPs have condemned the hate-fueled crime spree taking place against Christian churches, whereby nearly 100 churches since 2021 have been set on fire or burned to the ground across the country, and another 100 churches have been vandalized in the same period. The Conservative Party also came out, albeit late, against a Dec. 2024 report from the Liberal-dominated House of Commons Finance Committee which recommended that the government strip churches, Christian charities, and pro-life organizations of their charitable status. The report attacked churches directly by recommonding an amendment to the Income Tax Act "to provide a definition of a charity which would remove the privileged status of 'advancement of religion' as a charitable purpose". Neither Bernier nor the PPC have commented on the Liberal-NDP Finance Committee recommendation to strip all churches of their charitable tax status by removing "the advancement of religion" as a charitable purpose from the Income Tax Act.	 The NDP and its leader, Jagmeet Singh, are largely ignoring the wave of arson attacks that have consumed nearly 100 Christian churches (and counting) since 2021. Singh made only only one statement in July 2021 when the arsons happened, stating rather mildly that burning churches is wrong, but then proceeding to criticize church institutions in the same breath, which had the effect of watering down his condemnation of the arson. Neither the NDP nor its leader, Jagmeet Singh, have made any statement to defend churches and charitable organizations from the December 2024 House of Commons' Finance Committee report which recommended to the Liberal government, amongst other things, that it should strip churches of their charitable status by removing "the advancement of religion" as a charitable purpose from the Income Tax Act. In fact, the committee that made these recommendations was dominated by Liberal and NDP MPs. 	The CHP condemns the crime wave of church burnings that has taken place across Canada since 2021. The CHP strongly opposes recommendations 429 and 430 by the Liberal-NDP dominated House of Commons Finance Committee, which, in December 2024, counselled the government to remove charitable tax-exempt status from all churches, pro-life organizations, and many Christian charities,	The Green Party and its co-leaders have totally ignored the wave of arson attacks that have consumed nearly 100 Christian churches (and counting) since 2021. FREE SPEECH	Opposes free speech. The Liberal government has passed and introduced numerous laws which aim to censor speech and punish people with "hate crimes" for peacefully expressing their opinions (C-63) and by censoring the internet and social media platforms (C-11, C-18). Supports compelled speech. Believes in forcing Canadians to utter words in which they do not believe, in violation of their consciences. For example, the Liberals passed Bill C-16, a law which compels Canadians to refer to transsexuals and transvestites with made-up personal pronouns they do not believe in, like "Zhe" and "Zhir". Bill C-16 also forces Canadians to refer to biological males as if they were women, on pain of potential human rights complaints and/or criminal "hate speech" charges for non-compliance. LEGALIZING DRUGS	At its 2018 policy convention, Liberal party members passed a resolution to decriminalize possession and consumption of ALL illegal drugs, including cocaine, heroin, crack, fentanyl, etc. Liberals passed Bill 45 which legalized marijuana, the dangerous & highly-addictive gateway drug to harder narcotics. It permits 12-yr-olds to possess up to 10 joints. Under the Liberals, all drugs were decriminalized across British Columbia, including crack, cocaine, heroin & fentanyl. Public drug use was also permitted. Overdose deaths in B.C. have risen 338% since the Liberals came to power. Crime has exploded. The Trudeau government opened fifty so-called "safe injection sites" across the country where hard drugs could be consumed, even supplying free drugs to addicts in some locations.	voted almost unanimously against legalizing marijuana.
